SUBJECT: COUNTY SERVICE AREA NO. 9A RESIDENTIAL LIGHTING

ANNEXATION NO. 01-01, MESA VERDE

Members of the Board:

On February 27, 2001, the Board of Supervisors adopted a resolution setting today as the public hearing date on the proposed annexation of territory, Mesa Verde, to Zone A of County Service Area (CSA) No. 9. Further, your Board adopted a resolution of intention to authorize and levy an assessment for 9A residential lighting services for the proposed annexation. Lastly, as per Proposition 218 procedures, your Board directed the Department of Public Works to mail out ballots to the record owners within the annexation subject to the 9A assessment and set today as the public hearing date on the proposed assessment.

In order to complete the annexation of the Mesa Verde territory, it will be necessary for your Board to now open the public hearing, take testimony, and at the conclusion of the public hearing, consider the adoption of the attached resolution annexing territory known as annexation no. 01-01, Mesa Verde into CSA 9A. Further, your Board is required to take testimony and request ballots for the proposed CSA 9A assessments, which will then be tabulated by Public Works.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Open the public hearing, hear objections or protest if any, to the proposed annexation no. 01-O 1, Mesa Verde and CSA 9A assessment.
- 2. Request submittal of ballots on the proposed assessment.
- 3. Close the public hearing and consider adoption of a resolution annexing territory designated as annexation no. 01-01, Mesa Verde to CSA 9A residential lighting.

4. Direct the Department of Public Works to count the ballots on the proposed CSA 9A assessment and return to the Board of Supervisors with a tabulation and certification of the ballots on or before May 1, 200 1.

RESOLUTION ANNEXING TERRITORY KNOWN AS ANNEXATION NO. 01-01 MESA VERDE TO ZONE "A" (RESIDENTIAL STREET LIGHTING) OF COUNTY SERVICE AREA NO. 9

WHEREAS, this Board, by its Resolution No, initiated annexation
proceedings for the annexation of certain territory designated as Annexation No. 0 1-O 1 Mesa Verde
more particularly described in Exhibit "A" and shown upon a map designated Exhibit "B", both
attached hereto, to Zone "A" of County Service Area No. 9, and with proper notice set April 17,
2001, at 9:00 o'clock a.m. or thereafter, as the time for hearing on said matter; and

WHEREAS, the Board of Supervisors has determined that no exchange of property tax revenues will occur with this annexation in accordance with Resolution 3 59-80; and

WHEREAS, said hearing was held and all protests were heard, and a majority protest was not filed; and

WHEREAS, this Board considers annexation of said territory to be for the best interests of this service area and the territory concerned;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED THAT:

- 1. The boundaries of the area to be annexed are described in Exhibit "A" and shown upon a map designated Exhibit "B" both attached hereto and by this reference incorporated herein.
- 2. The territory described in Exhibit "A" and shown on Exhibit "B" be and hereby is annexed to Zone "A" of County Service Area No. 9.

BE IT FURTHER RESOLVED AND ORDERED THAT:

- 1. The Department of Public Works request the Auditor-Controller to submit a warrant to the Clerk of the Board, made out to the State Board of Equalization in the amount of \$500.00.
- 2. The Clerk of the Board shall file a certified copy of this resolution, a copy of the legal description and map, and said warrant with the State Board of Equalization in Sacramento.


ANNEXATION 01-01

SITUATE IN THE COUNTY OF SANTA CRUZ, STATE OF CALIFORNIA AND BEING A PORTION OF THE RANCHO DE LOS CORRALITOS IN PROJECTED SECTIONS 16 AND 17, TOWNSHIP 11 SOUTH, RANGE 2 EAST, MOUNT DIABLO BASE AND MERIDIAN AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT WHICH IS THE NORTHEASTERLY CORNER OF LOT 14 OF THE MESA VILLAGE SUBDIVISION NO.1, TRACT NO. 351, AS SHOWN IN VOLUME 40 OF MAPS PAGE 13, RECORDED IN THE OFFICE OF THE SANTA CRUZ COUNTY RECORDER, MAY 22, 1963.
