SUBJECT: APPLICATION FOR PEDESTRIAN SAFETY PROGRAM FUNDS

Members of the Board:

The California Department of Transportation is requesting applications from local agencies for the Pedestrian Safety Program, which will make \$20 million available on a one-year trial basis. Eligible projects may include, but are not limited to, traffic calming measures, intersection safety improvements, traffic signal timing, crosswalk construction or improvements, and any traffic safety or enforcement program authorized by law. Applications are due by May 22, 2001.

The Department of Public Works is proposing to submit an application for a pedestrian walkway along Sims Road from Graham Hill Road to Brook Knoll Drive for children attending the Brook Knoll Elementary School. Recently a private road was closed that was used by the children for access to the school. The children must now walk to school on Sims Road where there are no sidewalks and very little shoulder. The total project cost is estimated at \$352,500, and the grant application will be for \$282,500. Public Works proposes to match the grant with funds from Carbonera roadside fees, road funds, and Transportation Development Act funds.

It is therefore recommended that the Board of Supervisors adopt the attached resolution approving the filing of the grant application for **funds** from the Pedestrian Safety Program.

RESOLUTION APPROVING THE APPLICATION FOR THE PEDESTRIAN SAFETY PROGRAM

WHEREAS, the Pedestrian Safety Program is administered by the California Department of Transportation to provide federal funding for the construction of pedestrian safety and traffic calming projects that link to schools; and

WHEREAS, the County of Santa Cruz Department of Public Works has prepared an application for grant funding for the Pedestrian Safety Program; and

WHEREAS, Sims Road has been identified as a significant roadway in need of pedestrian improvements for the Brook Knoll Elementary School; and

WHEREAS, the application requests Pedestrian Safety Program funding in the amount of \$282,500.

- 1. Approve the filing of an application for the Pedestrian Safety Program;
- 2. Agree to act as the claimant for this grant and request funds, if the grant is approved;

Bolich, Director of Public Works, and the Department of Public Works as the official representative of Santa Cruz County to administer, execute, and submit all documents including, but not limited to: application, agreements, amendments, payment requests, etc., which may be necessary for the completion of the aforementioned project.
