

On April 4, 1999, my life changed forever in the blink of an eye. Because of a slight miscalculation on my part, of which I will spare you the details, I awoke as an incomplete C7 quadriplegic with standard issue halo and wheelchair- After four months in the acute spinal cord rehabilitation ward of the Santa Clara Valley Medical Center, I found myself living in Ben Lomond and continuing physical and occupational therapy at Dominican in Santa Cruz. This personal experience is largely why I feel I can contribute to the Long-term Care interagency Commission.

Prior to my injury, I was living in Alaska and working for State Senator Lyman F. Hoffman, primarily developing and carrying his personal legislation through the committee process and handling budget matters on behalf of his district. I believe my knowledge of political process and my ability to negotiate satisfactory compromise would serve me well as a member of the Commission.

Admittedly, there are vast differences between Alaska and California in many ways, however, first-hand experience of the issue, the ability to negotiate compromise and working knowledge of political systems are all about the same wherever you go.

I would very much like the opportunity to make a difference. and this Commission is a forum in which I believe I can do just that. And, although I am still working for Senator Hoffman by telecommute, I expect it to end at the conclusion of this year's legislative session in May. At that time I will continue my residency in Ben Lomond and hopefully join the ranks of the employed in a field where, like this Commission, I can work to make a difference.
