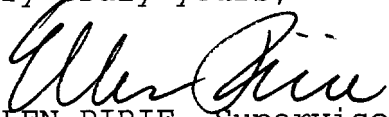

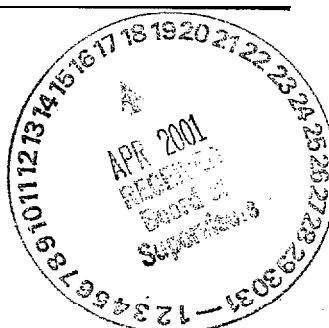

I have been a resident of the Second **Supervisory** District for 47 years. During that time I have served as a member of the Cabrillo Music Festival Board. I have also been privileged to serve as a member of the Cultural Council Board for twelve years, during which time I held the office of Spectra chairperson, vice-president and president of the Cultural Council. In 1999 I served as co-chair of the Santa **Cruz** County Cultural Action Plan.
