Members of the Board:

On June 27, 2000, your Board approved the Fish and Game Commission's recommendation to make an allocation for the purchase of equipment and a night vision scope for the California Department of Fish and Game. Funds for this allocation were re-budgeted into this fiscal year and realigned to fixed assets in October, 2000 to meet the budgetary requirements of the transaction. As the amount transferred to fixed assets for the night vision scope was insufficient to complete the transaction, we recommend that your Board approve the AUD-74 Request for Transfer of Appropriations and/or Funds in the amount of \$200.
