On June 27, 2000, your Board approved the Fish and Game Commission's recommendation to make an allocation for the purchase of equipment and a night vision scope for the California Department of Fish and Game. Funds for this allocation were re-budgeted into this fiscal year and realigned to fixed assets in October, 2000 to meet the budgetary requirements of the transaction.
