SUBJECT: 2000/200 1 PAVEMENT MANAGEMENT OVERLAY PROJECT

Members of the Board:

The specifications and engineer's estimate for the 2000/200 1 Pavement Management Overlay Project are complete and presented here for your Board's consideration and approval. The project will provide for the resurfacing of approximately 16 miles of County roads. The list of the proposed roadways in this year's program is attached. In this first year of the County's Pavement Management Program, which in addition to overlays also includes the slurry seal contract and the seal coat (chip seal) program, we expect to resurface more than 60 miles (10 percent) of our 600 mile road network. In order to keep the public apprised of road improvements scheduled in their area, we will be bringing a proposal back to your Board in May to facilitate this process.

The engineer's estimate for this project is \$6,750,000.00, not including contingencies and administration. Sufficient funds are available in the 2000/200 1 Pavement Management Program to cover this expenditure.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the specifications and engineer's estimate and authorize calling for bids for the 2000/2001 Pavement Management Overlay Project.
- 2. Set the bid opening for 10:45 a.m. on May 1, 2001.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning April 1, 2001, in accordance with provisions of the Public Contract Code Section 20392.
