REQUEST TO ADVERTISE REROOF OF 100 ROUNTREE LANE #00C1-016

Members of the Board:

As part of the 200012001 Plant Budget, your Board allocated funds for a licensed contractor to remove and replace approximately 33,880 sq. ft. of roofing at the Sheriffs detention facility at 100 Rountree Lane. Plans and specifications have been prepared by the General Services Department and Technical Roof Services, Inc. (TRS). These items and associated documents related to the project must be approved by your Board prior to solicitation of written proposals. The cost of the project is estimated to be \$180,000. Funds are available in Budget Index 191144, Sub-Object 6610.

It is therefore RECOMMENDED that your Board take the following actions:

- Approve plans and specifications on file with the Clerk of the Board for the Reroof of 100 Rountree Lane;
- 2. Direct the General Services Department to advertise for bids; and
- 3. Set the bid opening for 10:45 a.m. on March 27, 2001.
