**ORDINANCE AMENDING CHAPTER 13.10 OF THE  
SANTA CRUZ COUNTY CODE  
CHANGING FROM ONE ZONE DISTRICT TO ANOTHER**

---

The Board of Supervisors of the County of Santa Cruz ordains as follows:

SECTION I

The Board of Supervisors finds that the public convenience, necessity, and general welfare require the amendment of the County Zoning Regulations to implement the policies of the County General Plan regarding the 89 parcels listed in Section III below; finds that the zoning established herein is consistent with all elements of the Santa Cruz County General Plan; and finds and certifies that all environmental regulations specified in the California Environmental Quality Act, the State and County Environmental Guidelines, and Chapter 16.01 of the County Code have been complied with by the preparation and certification of the Environmental Impact Report for the project.

SECTION II

The Board of Supervisors hereby adopts the recommendations of the Planning Commission for the Zoning Plan amendment as described in Section III, and adopts their findings in support thereof without modification as set forth below:

1. The proposed zone district will allow a density of development and types of uses which are consistent with the objectives and land use designations of the adopted General Plan; and
2. The proposed zone district is appropriate for the level of utilities and community services available to the land; and
3.
  - I-I a) The character of development in the area where the land is located has changed or is changing to such a degree that the public interest will be better served by a different zone district; or
  - I-I b) The proposed rezoning is necessary to provide for a community related use which was not anticipated when the zoning plan was adopted; or
  - I-I c) The present zoning is the result of an error; or

- ☒ d) The present zoning is inconsistent with the designation shown on the General Plan.

### SECTION III

Chapter 13.10, Zoning Regulations, of the Santa Cruz County Code is hereby amended by amending the County Zoning Plan to change the following property from the existing zone district to the new zone district as follows:
