Re: Approval to transfer the allocation of funds in the Violence Against Women Vertical Prosecution (VAWA) grant, #VV97010440

Dear Members of the Board:

On May 23, 2000, your Board approved a time augmentation by the Office of Criminal Justice Planning (OCJP) that extended the original expiration date of February 28, 2000 to December 31, 2000 for the VAWA grant. This time augmentation allowed the District Attorney to expend the remainder of available funds awarded by this grant.

In order for the District Attorney to expend these funds, it is necessary to move \$1,640 in appropriations from Operating Expenses to Salaries. County policy requires Board approval for all reallocations between line items of the budgeted amount. This action shall allow the maximum utilization of available grant funds.

IT IS THEREFORE RECOMMENDED that the board approve the request of the District Attorney to decrease the allocation of Operating Expenses by \$1,640 and increase the Salaries by \$1,640.
