Authorization to Submit Subgrant Application

Dear Members of the Board:

On March 27, 2001, your Board authorized the County Office Of Emergency Services in its role as the County Operational Area to submit a non-competitive grant application to the State Office of Emergency Services - Coastal Region for the purpose of participating in the State Domestic Preparedness program. The first subgrant application in the amount of \$7.212 provided funding for an area needs assessment as required for program participants.

The second **subgrant** application (on file with the Clerk of the Board) involved working in collaboration with local jurisdictions in a task group to develop an equipment strategy based on the needs assessment. The task group, primarily law and fire agency representatives, has agreed upon a list of first responder equipment that is eligible under the program restrictions. The equipment listed in the second sub grant application focuses on standardization of hazardous materials response resources for improved on scene interagency coordination; the equipment list for the grant application is attached and is categorized as either personal protective or detection gear. With the full support of the local task group, **Scotts** Valley Fire Protection District has agreed to serve as custodian of the equipment in consideration of their hazardous materials team and mutual aid work with the Sheriff's Office Bomb Response Unit.

It is therefore recommended that your Board authorize the County Office of Emergency Services in its role as the County Operational Area to submit the **subgrant** application for the amount of \$51,642.28 for equipment needs as part of the Santa Cruz Opera-
