RE: Independent Contractor Agreement, Additional Encumbrance Law Enforcement Psychological Services Inc. Central Coast Polygraph

Dear Members of the Board:

The Sheriffs' Office contracts with a number of professionals who provide a wide variety of on-going services in support of our on-going law enforcement operations.

Law Enforcement Psychological Services Inc. conducts pre-employment psychological assessments to help determine the suitability of candidates for employment with the Sheriffs' Office in a law enforcement capacity. This company is eminently qualified to provide this service and provides assessments for most other local law enforcement agencies and several other County Departments as well. They have been providing this service to the Sheriffs' Office for over ten years and we are very satisfied with the quality of their work.

Central Coast Polygraph conducts pre-employment polygraph examinations with selected candidates for law enforcement positions with the **Sheriffs'** Office as part of the Departments background investigation process that all **of our** candidates participate in. These examinations also help determine the suitability of candidates for our law enforcement positions.

Due to expanded recruitment activities in an attempt to fill the current vacancies in the Sheriffs' Office, it has been necessary to utilize the services of Law Enforcement Psychological Services Inc. and Central Coast Polygraph more than originally anticipated to complete background investigations for prospective candidates for employment with the Sheriffs' Office. It is anticipated that Law Enforcement Psychological Services Inc. will conduct an additional 22 assessments, in FY 00/0 1, at an increased cost of \$6,050. It is also anticipated that Central Coast Polygraph will conduct an additional 20 assessments, in FY 00/01, at an increased cost of \$2,800.

Adequate appropriations currently exist in the Sheriffs' budget to fund the additional expenditures from both contracts through the end of this fiscal year.

It is therefore recommended that your Board take the following actions relating to these two agreements:

- 1. Approve an increased encumbrance of \$6,050 with Law Enforcement Psychological Services Inc. for the period July 1, 2000 through June 30, 2001 to conduct pre-employment psychological assessments.
- 2. Approve an increased encumbrance of \$2,800 with Central Coast Polygraph for the period July 1, 2000 through June 30, 2001 to conduct pre-employment polygraph exams.
