## RE: APPROVE AMENDMENT TO AGREEMENT FOR DATA BASE CONVERSION CONSULTANT SERVICES FOR THE EMERGENCY MEDICAL SERVICES PROGRAM

Dear Members of the Board:

On May 23, 2000, your Board approved an agreement in the amount of \$12,520 with CompuCounsel Consulting to provide database conversion and related services for the Emergency Medical Services (EMS) program. At this time, it is necessary to amend the scope of the agreement and to extend the agreement through June 30, 2002.

The amendment in the amount of \$6,980 with CompuCounsel will provide an additional refinement to the EMS Data Pro software package that will match fire and ambulance records for patients in the database and that will search free text fields for narrative data. The revised scope of work in the amendment will add \$6,980 to the agreement for a total amount of \$19,500. Sufficient appropriations exist in the existing HSA EMS budget for 2000/2001 and no new County funds are needed or requested to fund this change.

It is therefore RECOMMENDED that your Board:

1. Approve the attached amendment to the 2000/01 agreement with CompuCounsel Consulting, Contract No. 2163 (Budget Index 365002, Subobject 3665), increasing the contract by \$6,980 for a new contract maximum of \$19,500, and amending the ending date to June 30, 2002, and authorize the Health Services Agency Administrator to sign the contract.

# AMENDMENT TO AGREEMENT REVISION DATED 5/22/01 CompuCounsel Consulting

**2-REV 5/22/01.** <u>COMPENSATION.</u> In consideration for CONTRACTOR accomplishing said result, COUNTY agrees to pay CONTRACTOR as follows: an amount not to exceed **\$12,520.00** for the fixed cost items listed in Attachment A ("EMS Data Pro Implementation Proposal"), which by this reference is made part of this agreement; and an amount not to exceed \$6,980 for the fixed cost items listed in Attachment B ("EMS Software Upgrade Proposal"), which by this reference is made part of this agreement. COUNTY further agrees to pay a rate of \$145.00 an hour for additional consulting services as requested.
