CONTRACT AMENDMENT FOR CONSULTANT SERVICES TO DEVELOP PUBLIC GUARDIAN POLICIES AND PROCEDURES MANUAL

Dear Members of the Board:

In November 1999 your Board approved a contract for consultant services with Becket and Company to develop a Public Guardian policies and procedures manual. The original contract was approved for \$25,000. Becket and Company has completed approximately one-half of the project. The purpose of this letter is to request your Board's approval for an amendment to the contract with Becket and Company to complete the Public Guardian project.

Due to unforeseen circumstances regarding the availability of the contractor and staffing issues in the Public Guardian office, it is necessary to extend the contract period through December 31, 2001. There is no additional cost for this amendment. The original contract and the proposed amendment to extend the term of the contract are available in the Clerk of the Board Office.

IT IS THEREFORE RECOMMENDED that your Board authorize the HRA Administrator to sign the contract amendment with Becket and Company to extend the term of the contract.
