FINANCING FOR THE 2000/2001 PAVEMENT MANAGEMENT OVERLAY PROJECT

Dear Members of the Board:

On May 8, 2001, your Board as the Board of Supervisors accepted the low bid from Granite Construction Company and authorized award of the construction contract in the amount of \$5656,658 for the 2000/2001 Pavement Management Overlay Project as requested by the Director of Public Works. In order for Redevelopment Agency funds to be available to finance the portions of the work within the Live Oak/Soquel Redevelopment Project Area, additional action is required from you, as the Board of Directors for the Redevelopment Agency.

The contract for this project includes pavement overlay on a number of roads within the Live Oak/Soquel Redevelopment Project Area including 5th Avenue, 6th Avenue, Dolores Street, Thurber Lane, and Willowbrook Lane. The cost of construction on these roadways is being financed by the Redevelopment Agency. The Redevelopment Agency's share of the cost for the construction of these improvements, including overhead and contingency, is \$534,263. These costs are in addition to over \$1.0 million of Agency funding committed for the pavement management component of current construction projects.

In order to award this contract and cover the other construction related expenses it will be necessary to appropriate \$534,263 in pavement management funds, currently allocated but not appropriated for use this fiscal year. A Resolution authorizing that transfer is included as Attachment 1.

Redevelopment Agency staff has determined that the project is of benefit to the Project Area, that no other reasonable means of financing the improvements are available to the community, that the project will assist in the elimination of blight, and that the project is

consistent with the Redevelopment Agency's Five Year Implementation Plan.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the Redevelopment Agency, take the following actions:

- 1. Approve the attached Resolution Accepting Unanticipated Revenue totaling \$534,263;
- 2. Approve Agency funds totaling \$534,263 for the Agency's share of the cost of the construction 2000/2001 Pavement Management Program Overlay Project; and
- 3. Concur with and adopt the associated findings.
