SUBJECT: VIENNA WOODS SUBDIVISION STOP SIGNS

Members of the Board:

The Public Works Department, at the request of the residents in the Vienna Woods Subdivision, has completed a review of the need for additional stop signs along the County maintained roads in the area. Although none of the intersections meet vehicle volume or accident warrants for the placement of multi-way stops, several intersections do meet warrants to stop the minor street with the lesser flow of traffic. These locations are shown on the attached map, and are as follows:

1. On Cheryl Way at Vienna Drive
2. On Jennifer Drive at Danube Drive
3. On Jennifer Drive at Vienna Drive (both sides)
4. On Vienna Drive at Wilshire Drive
5. On Wilshire Drive at Danube Drive

These new stop sign locations should help to control the right of way and **turning** movements at the intersections.

It is therefore recommended that the Board of Supervisors consider adopting the attached ordinance in concept for the installation of new stop signs in the Vienna Woods Subdivision, and place the ordinance on the next available agenda for final adoption.





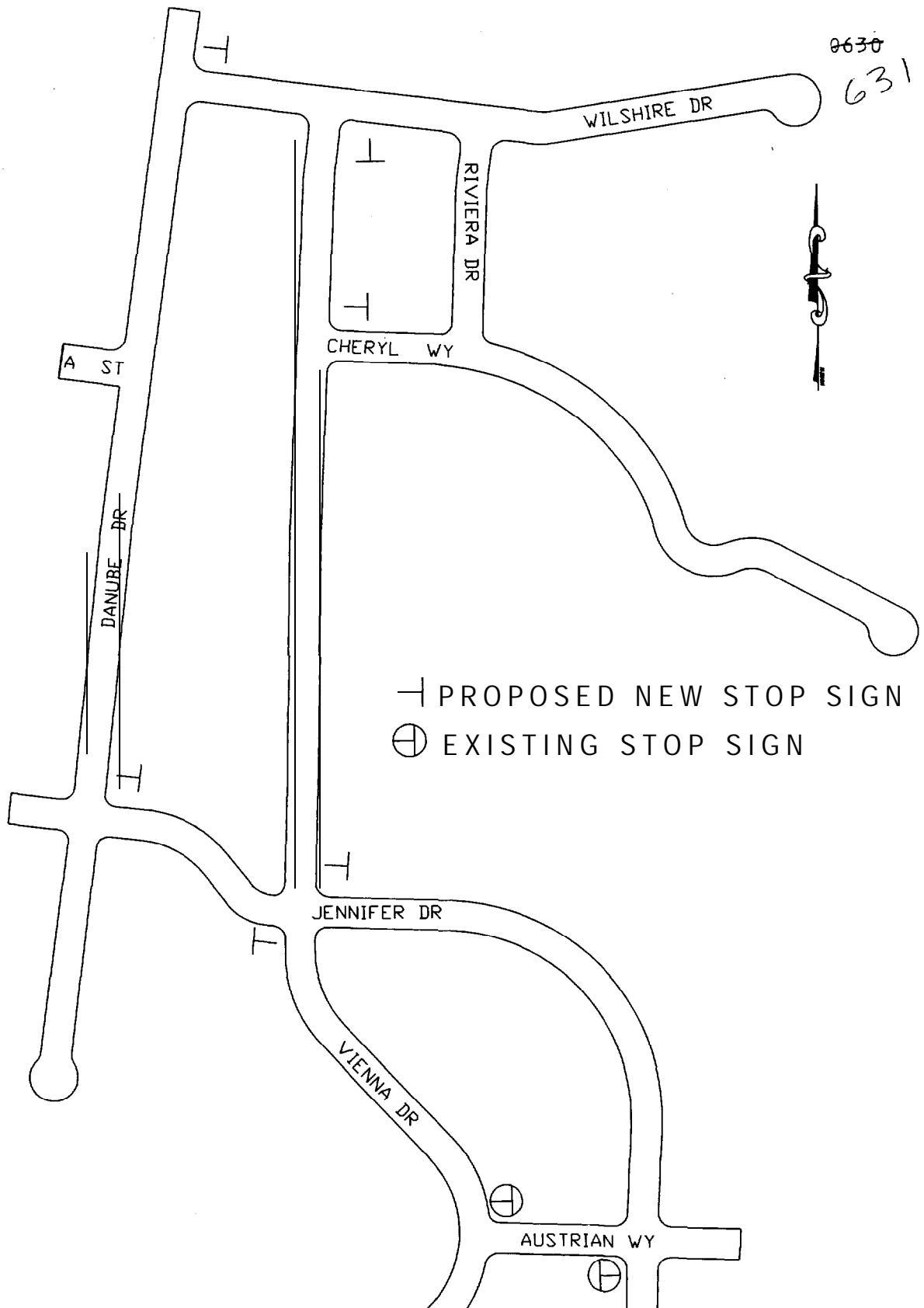
