RE: Request for the Reallocation of Funds for the Purchase of Fixed Assets

Dear Members of the Board:

The District Attorney is requesting your Board's approval for the reallocation of \$6,000 for the purchase of three (3) mobile radios to be installed in District Attorney Inspectors assigned vehicles. Funds for this purchase became available from savings within the fixed asset category of the District Attorney's FY2000-2001 budget.

The requirement for mobile radios in an inspector's unit is one of both safety and utility. District Attorney Inspectors respond to both active cases in concert with local law enforcement as well as in their role as investigators in support of prosecution efforts. The ability to have radio contact with both other inspectors as well as law enforcement is imperative to the routine duties of all inspectors.

The Radio Maintenance Shop has provided the specifications for the radios required by the Inspectors vehicles, and are identified below:
