Dear Members of the Board:

The available appropriations for salaries and benefits in the Elections Department (Index '214000) will be exceeded by approximately \$45,000 by year end as the result of extra help and overtime expenditures incurred in the process of providing technical assistance to the Redistricting project, and conducting elections this fiscal year. The available appropriations for salaries and benefits in the Clerk-Recorder's Department (Index 212000) will be exceeded by approximately \$11,000. Salary savings are available in the Treasurer Tax-Collector department budget (Index 731000).

In order to provide for the realignment of budgeted appropriations to meet estimated expenditures through the end of the fiscal year, it is RECOMMENDED that your Board approve the attached Transfer of Funds.
