Transfer Of Budget Appropriations

Dear Members of the Board:

During FY 2000-01 budget hearings your Board approved an appropriation of \$250,000 for fuel expenditures for the operation of County vehicles maintained by the General Services' Fleet Services Division.

As your Board is aware, California gasoline prices have increased substantially during this fiscal year which has resulted in higher than anticipated fuel expenditures for the Fleet Services Division. It is now projected that the Fleet Services Division's FY 00/01 fuel costs will be \$315,000 which represents a \$65,000, or 26% increase over our original budgeted appropriations.

Current appropriations within the Fleet Services Division budget, which operates as an internal services fund, are insufficient to absorb these increased fuel costs. Therefore it is necessary to request your Board's approval of a transfer of funds from fund balance in the amount of \$65,000 to the General Services' Fleet Services Division fuel budget.

In addition, a \$20,000 re-alignment, from salary savings to services and supplies, is necessary in our Technical Communications Division (radio shop) budget. This action is necessary to fund increased expenditures for required repair work on radio equipment by outside radio repair vendors due to staff vacancies.

Therefore, it is RECOMMENDED that your Board:

- 1. Approve a transfer of funds from Fund Balance and appropriate \$65,000 into the General Services' Fleet Internal Service Fund, index 333500, sub object 4160, to cover increased fuel expenditures for County vehicles.
- 2. Approve a \$20,000 transfer of appropriations within the General Services radio budget from salaries, index 303200, subobject 3100 to radio maintenance, index 303200, subobject 3360.
