

SUBJECT: AMENDMENT NO.1 TO COOPERATIVE AGREEMENT FOR STATE ROUTE

9 AND GLEN ARBOR ROAD - TRAFFIC CONTROL SIGNAL AND SAFETY

LIGHTING PROJECT

Members of the Board:

The California Department of Transportation (CALTRANS) has submitted for execution an original and four copies of Amendment Number 1 to Cooperative Agreement (#05-CA-0110) between the County of Santa Cruz and the State to extend the termination date of the original Cooperative Agreement from June 30, 2001, to June 30, 2003. The proposed County local match for the project is \$57,200 for the installation of a traffic control signal and safety lighting at State Route 9 and lower Glen Arbor Road. The project was delayed by the State because of past storm damage at the Highway 9 and Glen Arbor Road intersection that necessitated extensive highway repairs before it could be constructed.

CALTRANS has requested that the original and four copies of Amendment 1 to Cooperative Agreement be signed by the Board Chairman and a resolution authorizing the amendment be provided for each copy. After signature by the appropriate CALTRANS officials, the County will be furnished a fully executed copy of the amendment for Public Works' files.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the attached Amendment 1 to Cooperative Agreement Number 05-CA-0110 between the State of California and County of Santa Cruz for the installation of a traffic control signal and safety lighting at State Route 9 and Glen Arbor Road.

- 2. Adopt the attached Resolution authorizing the execution of the Amendment 1 to Cooperative Agreement.
- 3. Direct the Clerk of the Board to return the signed Amendment 1 to Cooperative Agreement and four copies with authorizing resolution to the State of California Department of Transportation.

RESOLUTION AUTHORIZING EXECUTION OF AMENDMENT NUMBER 1 TO COOPERATIVE AGREEMENT (#05-CA-0110) BETWEEN THE COUNTY OF SANTA CRUZ AND STATE OF CALIFORNIA FOR THE CONSTRUCTION OF A TRAFFIC CONTROL SIGNAL AND SAFETY LIGHTING AT STATE ROUTE 9 AT GLEN ARBOR ROAD

WHEREAS, the County of Santa Cruz has entered into a Cooperative Agreement with the California Department of Transportation (CALTRANS) to share in the actual cost of construction of a traffic control signal and safety lighting at State Route 9 and Glen Arbor Road; and

WHEREAS, CALTRANS agrees to design and construct the traffic control signal and safety lighting at State Route 9 and Glen Arbor Road; and

WHEREAS, CALTRANS agrees to maintain and operate the traffic control signal and safety lighting at State Route 9 and Glen Arbor Road; and

WHEREAS, the County agrees to fund the electrical energy costs for the traffic control signal and safety lighting at State Route 9 and Glen Arbor Road; and

WHEREAS, the County of Santa Cruz and CALTRANS agree that the agreement should be extended to June 30, 2003 through Amendment 1 to Cooperative Agreement (#05-CA-0110).

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that said Amendment 1 to Cooperative Agreement (#05-CA-0110) is hereby approved.

BE IT FURTHER RESOLVED AND ORDERED that the Clerk of the Board is directed to return the original and four copies with a certified copy of the authorizing Resolution attached to each copy to Kristine Ellingson, Department of Transportation, 50 Higuera Street, San Luis Obispo, California 93401-5415.

### **AMENDMENT #1 TO AGREEMENT**

THIS AMENDMENT TO AGREEMENT, ENTERED INTO ON	, is between the STATE OF
CALIFORNIA, acting by and through its Department of Transportation, referred to he	rein as STATE, and

COUNTY of Santa Cruz a political subdivision of the State of California, referred to herein as "COUNTY"

### **RECITALS**

- 1. The parties hereto entered into an Agreement (Document No. 014769) on April 7, 2000, said Agreement defining the terms and conditions of a project to install a traffic control signal and safety lighting on State Route 9 and Glen Arbor Road (PM 8.1) in the County of Santa Cruz, referred to herein as "PROJECT".
- 2. The parties hereto also entered into an Agreement (Document No. 013533) on June 25, 1996, to accomplish the project, however, too much time had elapsed for that Agreement to be amended after it expired, necessitating a new Agreement (hence Document No. 014769 was entered into superceding and replacing Document No. 013533).
- 3. Said Agreements set STATE's total PROJECT obligation at a maximum of \$88,440 from the 1996/97 Minor B Program. It has been determined that STATE's total PROJECT obligation will exceed that amount and that the 1996/97 funding will lapse after June 30, 2001. PROJECT will therefore be funded from the 2001/02 Minor B Program. It has also been determined that PROJECT will not be constructed prior to the termination dete of said Agreement, also June 30, 2001.

#### IT IS THEREFORE MUTUALLY AGREED:

- 1. STATE's total obligation specified in Section I, Article (3) of the latest Agreement (Document #014769) shall now not exceed the amount of \$115,800. COUNTY's estimated deposit specified in Section II, Article (1) in Document #014769 shall now be \$57,200. COUNTY's total obligation for said anticipated PROJECT costs, exclusive of claims and excluding costs referred to in Section III, Article (9), under this Agreement shall not exceed the amount of \$62,920. Revised Exhibit A, attached and made a part of this Amendment to Agreement, supersedes Exhibit shown in the superceding Agreement.
- 2. The termination date specified in Section III, Article (17) of the original Agreement shall now be June 30, 2003 instead of June 30, 2001.
- 3. The other terms and conditions of said Agreement (Document No. 014769) shall remain in full force and effect.

4. This Amendment to Agreement is hereby deemed to be a part of Document No. 014769.
