SUBJECT: HAPPY VALLEY ROAD CULVERT REPLACEMENT PROJECT OFFICE OF EMERGENCY SERVICES 96-07, DSR NO. 011

Members of the Board:

The plans, specifications, and engineer's estimate for the subject storm damage repair project are now complete and presented here for your consideration and approval. The work provides for the replacement of a culvert bridge that was destroyed during the December 1996 winter storms.

The project, as presented, is limited to those repairs included in the approved Damage Survey Reports (DSR), so as to return the damage sites to their original predisaster condition. The plans and specifications thus provide for a repair which essentially matches the existing roadway in the vicinity of the repair site, pursuant to the Office of Emergency Services' (OES) approved scope of work and available funding. In those instances where the funding approved for a DSR repair falls short of the actual bid price, we will submit a supplemental funding request to OES requesting that they cover the full cost of repair.

The engineer's estimate for this work is \$250,000, not including contingencies or administration costs. Sufficient funding for the project was included in the approved 2000/2001 Road Program.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids for the Happy Valley Road Culvert Replacement Project
- 2. Set the bid opening for 10:45 A.M. on June 26, 2001, with award directed that same day prior to the Board of Supervisors' summer recess.
- 3. Direct the Clerk of the Board to advertise a Notice to Contractors for a 10-day period beginning June 9, 2001, in accordance with the provisions of Public Contract Code Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., June** 26, **2001**, and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County road in accordance with the specifications therefor, to which special reference is made, as follows:

Happy Valley Road, Culvert Replacement P.M. 0.40, OES No. 011

This project involves the reconstruction of an existing cmp culvert with a new prefabricated reinforced concrete culvert bridge at Happy Valley Road, P.M. 0.4. Work includes wingwalls, pavement reconstruction, and stream mitigation by staged construction.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required.

The successful bidder shall furnish a payment bond and a performance bond.

The contractor shall possess a Class A license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
