SEWER SERVICE CHARGE REPORT, SUPERVISORIAL DISTRICT 5

Members of the Board:

On May 22, 2001, the Board of Supervisors adopted a resolution establishing the sewer service charge rate for Graham Hill County Service Area (CSA) No. 57 and further set today as the public hearing date on the 2001/2002 Sewer Service Charge Report for CSA No. 57, Graham Hill.

In order to complete the 2001/2002 sewer service charge rate proceedings, it will be necessary for your Board to now open the public hearing, take testimony, and consider objections and protests, if any, to the Sewer Service Charge Report, and at the conclusion of the public hearing adopt the attached resolution confirming the Sewer Service Charge Report for CSA No. 57 Graham Hill. As required by law, the Sewer Service Charge Report must be approved by your Board and forwarded to the Auditor/Controller by August 10, 2001.

It is therefore recommended that the Board of Supervisors take the following action:

1. Open the public hearing, hear objections or protest, if any, to the 2001/2002 Sewer Service Charge Report for CSA No. 57, Graham Hill.

2. Close the public hearing and at the conclusion of the hearing adopt the attached resolution confirming the 2001/2002 Sewer Service Charge Report for CSA No. 57, Graham Hill.
