SUBJECT: RIGHT-OF-WAY SURVEYS FOR MATTISON LANE AND MACIEL AVENUE

Members of the Board:

Under an existing contract for land surveying services, Bridgette Land Surveying has completed extensive research on Mattison Lane and Maciel Avenue road rights-of-way. This survey work resolved many historic discrepancies regarding the right-of-way and roadway alignment.

In order to preserve the results of the survey research, Public Works recommends that the survey be referenced to the County's Global Positioning System (GPS) network and permanent monumentation be set. Bridgette Land Surveying estimates that it will cost an additional \$10,000 to reference the survey to the GPS network, set monuments, and produce a record of survey map. This would bring this total not-to-exceed contract cost to \$40,000. Funds for this work are available in the Monumentation Program budget.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the attached amendment to agreement with Bridgette Land Surveying in an increased amount of \$10,000 to include the additional monumentation work on Mattison Lane and Maciel Avenue.

2. Authorize the Director of Public Works to sign the agreement.


