APPROPRIATION INCREASES FOR THE PLANT ACQUISITION BUDGET, THE CAPITAL PROJECTS BUDGET AND THE COUNTY LIBRARY FUND BUDGET

Dear Members of the Board:

Attached for your Board's approval are Transfers of Funds and Resolutions Accepting and Appropriating Unanticipated Revenue to:

- provide the necessary additional appropriations in the amount of \$245,660.50 in the Plant Acquisition Budget and the Capital Projects Budget for previously authorized consultants and special counsel work in the matter of defects in the County's 1400 Emeline Street Building; and
- increase appropriations by \$317,937 in the County Library Fund to conform the 2000-01 Library Fund Budget to the Estimated/Actual Revenue and Expenditure amounts included in the 2001-02 Proposed County Budget.

The increase in appropriations is necessary to satisfy the County's contractual obligation to the Library Finance Authority and to fund the revenue estimates provided to the Watsonville Library and Santa Cruz City/County Library System.

At this time it is RECOMMENDED your Board take the following actions:

1. Approve a Transfer of Funds in the amount of \$245,660.50 from the County's General Fund Contingency to the Plant Acquisition Budget for the 1400 Emeline Street Building and adopt a Resolution Accepting and Appropriating Unanticipated Revenue in the amount of \$245,660.50 from the Plant Acquisition Budget to the Capital Projects Budget.

WHEREAS, the County is a recipient of funds in the amount of \$174,945 which are in excess of those anticipated in the current fiscal year budget of the County; and

WHEREAS, pursuant to Government Code Section 29130 (c)/ 29064 (b), such funds may be made available for specific appropriation by four-fifths vote of the Board of Supervisors; and
