YEAR END TRANSFER OF FUNDS

Dear Members of the Board:

The Detention Bureau estimated actual expenditures for fiscal year 2000-2001 reflect increased costs in excess of budget appropriations in the categories in services and supplies. The primary overdraft occurred in the maintenance of kitchen equipment and several necessary maintenance projects at the Main Jail.

The maintenance related to the kitchen equipment has incurred costs that will exceed the appropriation by \$65,120. * Most of the kitchen equipment at the Main Jail is over 13 years old, and is the original equipment purchased when the Water Street Jail opened. This equipment is used to provide over 1,050 inmate meals a day. Most of our equipment is wearing out and needs more maintenance than what was anticipated.

During the past year the Main Jail has been under a major remodeling for the electronics security system and inmate dorm areas. During this process is was necessary to repair and/or maintain items that were identified such as upgrading additional wiring, adding camera's, notification switches for the attorney visiting areas and upgrading our visiting telephone equipment. It is anticipated that we will exceed our appropriation by \$77,228.

It is therefore recommended that you Board:

- 1. AUTHORIZE the transfer of **funds from** salaries and benefits to services and supplies in the amount of \$142,348 in the Sheriffs Detention Bureau;
- 2. APPROVE the attached request for transfer of budget appropriations (AUD74).
