SUBJECT: SOQUEL DRIVE (BARGETTO) BRIDGE REPLACEMENT AND

STREETSCAPE PROJECT

Members of the Board:

Included in the 2000/2001 Public Works Road budget are funds for the construction of a new bridge over Soquel Creek at Soquel Drive and road and streetscape improvements to Soquel Drive in the Soquel Village area and for the acquisition of the required right-of-way. The bridge replacement project is being constructed with federal funds and a local funding share provided by the Redevelopment Agency. The Porter Street right turn lane and Soquel Drive streetscape project is being constructed with Redevelopment Agency funds and developer fees.

The current plans for the Soquel Drive (Bargetto) Bridge Replacement and Streetscape Project include installing landscape trees along the sidewalk and in front of the business at 4771 Soquel Drive. The new trees will interfere with the sight lines to an existing business sign located on the property. The business sign will need to be relocated or replaced to be seen effectively **from** Soquel Drive after the project is completed. The attached contract provides for compensation to the owner for all costs associated with moving or replacing this sign. The settlement amount for this property severance damage is shown in the attached Resolution and is based on a departmental appraisal and negotiated settlement. This amount is considered fair and reasonable for such damages.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the County of Santa Cruz does hereby accept the terms of said contracts listed below:



CONTRACT COUNTY OF SANTA CRUZ

This supplemental contract is entered into this (21) day of April, 2001, by and between the COUNTY OF SANTA CRUZ, hereinafter called COUNTY, and Gregory L. Cramblit hereinafter called SELLERS. The parties mutually agree as follows:

The parties herein set forth the whole of their agreement. The performance of this agreement constitutes the entire consideration for this transaction.

WHEREAS, due to the construction of the new Bargetto Soquel Drive Bridge Project, which includes landscape trees in **front** of 4771 **Soquel** Drive, the SELLERS of the before mentioned property (APN: 30-082-32) have submitted a claim to the COUNTY for damages loss of sight to their **signage**. The SELLERS claim that they will have to change the location of their **signage** and/or replace their existing signs to be seen effectively from Soquel Drive. This may require permits from the COUNTY'S Planning Department. A negotiated settlement of \$1,500.00 was estimated by both COUNTY and SELLER to effectively reimburse SELLER for his loss of **signage**. The Department of Public Works in conjunction with the County Redevelopment Agency find that this amount is reasonable compensation for said damages and recommends payment of this amount.

NOW, THEREFORE, the COUNTY shall pay to the undersigned SELLERS the sum of \$1,500.00 for Severance Damages resulting from loss of signage on the SELLERS property and SELLERS shall hereby release and forever discharge the COUNT Ytrom responsibility for any and all damages done to SELLERS property at 4771 Soquel Drive due to the loss if signage caused by the construction and landscaping of the Bargetto-Soquel Drive Bridge Project, and any other claims or causes of actions that SELLERS have or may have due to the construction of the Bargetto-Soquel Drive Bridge Project as of the date of this Contract. This release from liability applies only to conditions or damages currently existing at the time of completion of the Bargetto-Soquel Drive Bridge Project.
