

SUBJECT: INCREASE IN THE RECORD OF SURVEY CHECKING FEE

Members of the Board:

One of the responsibilities of the County Surveyor is the review of Record of Survey maps prepared by surveyors and engineers in private practice prior to the maps being submitted to the County Recorder for recordation. This review is required by the California Business and Professions Code, and includes the execution of a County Surveyor's Statement that the map has been examined for conformance to the Code.

This service is funded by fees, currently set at a flat rate of \$250. The cost of providing this review is now exceeding this fee amount.

Staff has determined that the fee for reviewing Record of Survey maps should be increased to \$300 in order to cover our actual costs. This new fee has been included in the proposed Unified Fee Schedule.

It is therefore recommended that the Board of Supervisors consider adopting the attached ordinance in concept increasing the Record of Survey checking fee from \$250 to \$300, and place the ordinance on the next available agenda for final adoption.

## ORDINANCE AMENDING CHAPTER 2.18 OF THE SANTA CRUZ COUNTY CODE ESTABLISHING RECORD OF SURVEY CHECKING FEES

The Board of Supervisors ordains as follows:

### SECTION I

Chapter 2.18 of the Santa Cruz County code is hereby amended to read as follows:

### 2.18.20 Record of Survey Examination Fee.

Pursuant to Business and Professions Code Section 8766.5, the County Surveyor may charge a reasonable fee for examining a Record of Survey. The fee charged for examining a Record of Survey is hereby established at \$300.00 based on the staff report accepted and filed at the Board's regular June 19, 2001, meeting.
