## Members of the Board:

The subject project was completed on June 11, 2001. The Contractor was Legg Inc. The original bid amount was \$73,982. There have been four change orders to this project, approved by the Director of General Services in the amount of \$2,164.88, as authorized by your Board. These changes included additional door lock hardware, changes to screws on window stops, the addition of bushhammer sawcut openings and the deletion of certain paint materials. The total construction cost is now \$76,146.88.

Therefore it is RECOMMENDED that your Board take the following actions:

- 1) Accept the project as completed;
- 2) Approve the final cost of \$76,146.88; and
- 3) Authorize the Clerk of the Board to file the executed Notice of Completion with the Office of the County Recorder, a copy of which is attached.
