SUBJECT: LOMOND TERRACE ROAD IMPROVEMENT PROJECT, PHASE 2
LOMOND TERRACE, COUNTY SERVICE AREA NO. 28 (DISTRICT 5)

Members of the Board:

The specifications and engineer's estimate for the Lomond Terrace Road Improvement Project, Phase 2 are complete and presented here for your consideration and approval. The project will provide for the reconstruction of portions of the existing roadway through **digouts** and application of a 2-inch pavement overlay at the locations indicated on the plan.

The engineer's estimate for this project is \$26,000.00, not including contingencies and administration. Sufficient funds are available in the County Service Area No. 28 budget to cover this expenditure.


It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the specifications, and engineer's estimate and authorize calling for bids on Lomond Terrace Road Improvement Project, Phase 2.
2. Set bid opening for 10:45 a.m. on August 7, 2001.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning July 1, 200 1, in accordance with provisions of the Public Contract Code Section 20392.
