Members of the Board:

The plans, specifications, and engineer's estimate for the Via Palo Alto to Via Compana Stairway Rehabilitation Project, Aptos Seascape County Service Area (CSA) No. 3 are complete and presented here for your consideration and approval. The project proposes to replace an existing wood stairway.

The engineer's estimate for this project is \$50,000.00, not including contingencies and administration costs. Sufficient funds are available in the proposed CSA No.3, 2001/2002 budget to cover this expenditure.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids on the Via Palo Alto to Via Compana Stairway Rehabilitation Project, Aptos Seascape CSA No. 3.
2. Set bid opening for 10:45 a.m. on August 7, 2001


The work to be done consists, in general, of the replacement of an existing wood stairway.

No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
