EAST ZAYANTE ROAD, PM 2.77, 5.04, AND 6.85 AND SUBJECT:

UPPER EAST ZAYANTE ROAD, PM 3.16 STORM DAMAGE REPAIR

DSRNOS. 59191, 27237, 59193 AND 27300

Members of the Board:

The plans, specifications, and engineer's estimate for the subject project are now complete and presented here for your consideration and approval. The work provides for the repair of four individual Federal Emergency Management Agency (FEMA) Disaster Survey Reports (DSRs) written after the 1998 El Niño storm. The DSRs are for repair of damage on East Zayante Road at Post Miles (PM) 2.77, 5.04, and 6.85 and Upper East Zayante Road, PM 3.16. The repair methods range from minor culvert repair to slope stabilization using concrete cribwalls and rock slope protection.

The project, as presented, is limited to those repairs included in the approved DSRs, to return the damaged sites to their original predisaster condition. The plans and specifications provide for repairs that essentially match the existing roadway in the vicinity of the repair sites, pursuant to the FEMA approved scope of work and available funding. In those instances where the funding approved for a DSR repair falls short of the actual bid price, we will submit a supplemental funding request to FEMA requesting that they cover the full cost of repair.

The engineer's estimate for this work is \$290,000, not including contingencies or administration costs. Sufficient funding for the project is included in the proposed 2001/2002 Road Program.



In order to allow sufficient time for the administrative process involved between the time of bid opening and contract award, and to provide for the largest potential number of bidders during this heavy construction season, it will be necessary to open bids prior to the first available Board meeting in August 200 1. Public Works is therefore requesting that the Board allow the opening of sealed bids for the subject project in the office of the Director of Public Works on July 24, 2001. The resultant low bid would then be returned for the Board's acceptance on August 7, 2001. It would be Public Works' intention to request authorization to award the project to the low bidder on that same Board date.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids for the East Zayante Road, PM 2.77, 5.04 and 6.85 and Upper East Zayante Road, PM 3.16 Storm Damage Repair.
- 2. Set the bid opening for 10:45 A.M. on July 24, 2001.
- 3. Adopt the attached resolution allowing the bid opening for the subject project to take place in the office of the Director of Public Works at 10:45 a.m. on July 24, 2001, with acceptance and award by the Board on August 7, 2001.
- 4. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning July 1, 200 l, in accordance with the provisions of Public Contract Code Section 20392.

This project involves the construction of rock slope protection, concrete cribwall, pavement repair, drainage facilities, asphalt concrete dike, metal beam guard railing, and erosion control and revegetation. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time that this contract is awarded. The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
