NOTICE OF COMPLETION FOR MAIN JAIL SECURITY UPGRADE PHASE 1B

### Members of the Board:

The subject project was completed on June 30, 2001. The Contractor was Norment Security Group. The original bid amount was \$439,677. The project called for the upgrade of the central control security systems; the addition of a new central control sallyport; the upgrade of CCTV cameras; the addition of new intercoms, the reconstruction of attorney visiting rooms, the upgrade of the central guard area; the construction of a new line-up area; the construction a new inmate showers and modifications to improve lighting in inmate housing areas. On November 14, 2000 your Board approved an amendment to the agreement to repair and replace the shower exhaust system, increase the water line from 1/2" to 3/4", provide structural support to the shower walls, rewire the electrical, and make other modifications for \$142,865. In addition, there have been four (4) change orders to the project, approved by the General Services Director in the total amount of \$10,184. These changes included the relocation of a window in the visiting room, a T-bar ceiling system for Central Control, the replacement of an existing counter and the raising of the floor level to match the hallway floor. The total construction cost is now \$592,726.

Therefore it is RECOMMENDED that your Board take the following actions:

- 1) Accept the project as completed;
- 2) Approve the final cost of \$592,726; and
- 3) Authorize the Clerk of the Board to file the executed Notice of Completion with the Office of the County Recorder, a copy of which **is** attached.
