### **Approve Probation Department Agreements Related to the Crime Prevention Act of 2000 and Juvenile Accountability and Incentive Block Grant Programs**

Dear Members of the Board:

The adopted FY 2001-02 budget for the Probation Department includes funds for the provision of contracted services by community-based organizations in support of the Crime Prevention Act of 2000 (CPA 2000) and Juvenile Accountability and Incentive Block Grant (JAIBG) programs.

Your Board approved the proposed CPA 2000 and JAIBG program plans on April 17, 2001, establishing the Community Action Program (CAP) in the Probation Department. CAP was designed to incorporate CPA 2000 and JAIBG funds to provide a comprehensive countywide, research-based program that ~~will~~ have a measurable impact on reducing recidivism, payment of restitution, completion of community service, and successful completion of probation for juvenile offenders. After considerable analysis, meetings and discussions with juvenile justice practitioners, inter-agency partners and community members, two distinct program models were developed. The first program model is the Community Accountability Program (CAP), a strategy to build upon family resource centers to provide community and neighborhood interventions and services. The second program model is the Strength-Based Treatment, Assessment and Recovery (STAR) program, a short-term residential treatment option for youth in the juvenile justice system struggling with substance abuse and multiple risk factors, replacing the existing Redwoods Program. Contracted supportive services from local community-based organizations are an important component of each program.


