**SUBJECT: INSTALLATION OF NEW RESIDENTIAL STREET LIGHT WITHIN COUNTY
SERVICE AREA NO. 9, ZONE A**

Members of the Board:

The Department of Public Works has received a petition (copy attached) from residents of South Drive, off Buena Vista Drive in the Watsonville area, requesting the installation of one new street light at the location shown on the attached map. This area is within the County's residential street lighting district, Zone A of County Service Area No. 9. The petition is signed by all residents or property owners in the immediate vicinity of the proposed light.

The supervisor of this area is aware of the request for the additional light and is in favor of the installation.

The Pacific Gas and Electric company has advised us that the installation of a 70-watt residential street light is feasible on the existing pole. The installation will result in a charge of approximately \$7.75 per month on the County's street lighting bill. Adequate funding exists for this new light.

It is therefore recommended that the Board of Supervisors authorize the installation of one 70-watt residential street light on South Drive.


