## SUBJECT: TRAFFIC SIGNAL AND HIGHWAY SAFETY LIGHTING MAINTENANCE CONTRACT, REPUBLIC ELECTRIC

Members of the Board:

On August 13, 1998, your Board approved an independent contractor agreement with Republic Electric for traffic signal and highway safety lighting maintenance and authorized the Director of Public Works to sign the agreement. The term of this agreement was for a period of three years from the date of approval (currently set to expire on August 25, 2001), at which time it may be extended by mutual agreement between the contractor and the County on a year-to-year basis. Funds are available and have been appropriated in the County Service Area Number 9 Highway Safety Budget.

Republic Electric, over the past three years, has proven to be a reliable contractor with the experience, personnel, equipment, and knowledge to effectively maintain our traffic signals and highway safety lights. Its prompt service and attention to duty, along with a very helpful staff, have made our County highways a safer place for motorists, bicyclists, and pedestrians to travel.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the attached amendment to agreement with Republic Electric extending the term of the contract to June 30,2002.


