On June 26, 2001, Public Works requested the Board's authorization to advertise the subject project and to open bids on July 24, 2001, in the office of the Director of Public Works. Three bids were received, and all bids were found to be in order. The engineer's estimate was \$274,445.00. The low bidder was J. C. Randolph, Inc., of Aptos in the amount of \$303,772.50. Sufficient funds are available in the approved 2001/2002 Road Program to cover this expenditure including contingencies and administration.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of J. C. Randolph, Inc. in the amount of \$303,772.50 and authorize the award of contract.


