Redistricting of Supervisorial Boundaries - Public Hearing on Proposed Plans

Dear Members of the Board:

On June 26, 2001 your Board took a number of actions related to the redistricting of Supervisorial boundaries. Your Board:

- considered two plans proposed by your Board's representatives on the ad hoc redistricting committee;
- e received comment from members of the public on the proposed plans;
- unanimously agreed to **a** single county-wide plan, which reflected an agreement by the 4th and 2nd District Supervisors regarding the proposed boundaries of those **Districts**;
- directed staff to move forward to a public hearing with a map of the redistricting plan proposed by your Board, and with a map that demonstrated an alternative plan for the 2nd and 4th District boundaries, which was presented by the Santa Cruz County and Watsonville League of Latin American Citizens (LULAC): and
- opened a period for public comment on the proposed plans, and set a public hearing on the redistricting of Supervisorial boundaries for 7:30 p.m. on August 7, 2001 in the Board Chambers, located at 701 Ocean Street in Santa Cruz.

Redistricting Guidelines

As your Board will recall, the statutes governing redistricting direct that in establishing the boundaries of the districts, the Board may give consideration to the factors of a) topography, b) geography, c) cohesiveness, contiguity, integrity and compactness of territory, and d) community of interests of the districts. In addition, districts "shall be as nearly equal in population as may be and shall comply with the applicable provisions of (the Voting Rights Act of 1965) Section 1973 of Title 42 of the United States Code, as amended." County Counsel has advised that race is to be given consideration in the redistricting process so as to assure that sufficiently large minority populations in geographically compact areas which have similar communities of interest are kept together without being overly compacted.

In addition, your Board agreed on a set of principles to guide the process:

• to the extent possible, the current district boundaries will be preserved;

- the public will have all the opportunities provided by law to participate in the redistricting process, and provide input to the Board;
- communities of interest will be preserved to the extent possible; and
- each Supervisor would have the opportunity to suggest changes to his or her district's boundaries to the extent that such changes are necessary, prior to the public hearings to be held on the redistricting plan.

Board of Supervisors' Proposed Plan

Your Board's proposed plan recommends that Precinct **5116** be transferred from the Fifth District to the Third District, and that Precinct **3009** be transferred from the Third to the First District. The transfer of Precinct **5116** responds to the population discrepancy that exists currently between the Third and Fifth districts, and **its** location, essentially the top of Ocean Street area, retains a community of interest for the Third District in the City of Santa Cruz, and of the majority of the UCSC campus and campus housing, now given the student population housed at the former Holiday Inn. Precinct **3009** is located in the Twin Lakes area, and a proposed transfer from the Third District to First District reunites the unincorporated Twin Lakes neighborhood with the rest of unincorporated Live Oak, and establishes **7**th Avenue as the line of demarcation between the Third and First Districts.

Finally, the plan recommends that City of Watsonville precinct 4333 and unincorporated area Precincts 4010, 4011, 4013, 4015, the portion of 4018 which lies west of Green Valley Road, 4024, 4027, and 4028 be transferred from the 4th to the 2nd District. This transfer is intended to respect geographical communities that share common interests, retains a favorable balance if residents in the unincorporated and incorporated area, addresses the community of interest that the City of Watsonville remains largely in the 4th District.

The Board of Supervisors' proposed Redistricting plan for the County of Santa Cruz provides for the following population schedule:

Santa Cruz County and Watsonville League of United Latin American Citizens (LULAC) Proposed Alternative for the 2nd and 4th District Boundaries

On June 25, 2001 LULAC placed on file with the Clerk of the Board a proposed alternative plan for the 4th and 2nd District boundaries, and presented their plan to your Board on June 26th. The plan recommends that the 4th District include all precincts in the City of Watsonville, as well as unincorporated area precincts 4001, 4007, 4008, 4010, 4014, the portion of 4018 east of Green Valley Road, 4020, 4021, and 4031. Written correspondence from the League indicated that the proposed alternative for the 4th and 2nd District boundaries would "take into account many aspects, including but not limited to communities of interest, economics, voting history, housing factors, political affiliations, and other socio-economic factors."

The League's plan provides for the following population statistics for the 2nd and 4th Districts:

Maps demonstrating your Board's county-wide plan and the LULAC alternative for the 2^{nd} and 4^{th} District boundaries are attached for your reference.

Table of Statistics

During your Board's recess, staff placed on file with the Clerk, and provided to each Board office maps demonstrating your Board's county-wide plan and the LULAC alternative for the 2nd and 4th District boundaries, and a sheet with statistics tables. Two data elements in the table for the current district boundaries were inadvertently misprinted. The percent of the population that is Hispanic for the 4th District under the existing boundaries was stated as 72.9%. The actual figure is 70.9%. The percent of the population that is Hispanic for the 5th District under the existing boundaries was stated as 4%. The actual figure is 8%. The data under the existing boundaries was correctly interpreted in the redistricting software that was available to the ad hoc redistricting committee and to members of the public at the public use computer in the Elections Department. A table with the actual data is attached. A copy has been placed on file with the Clerk of the Board.

Public Hearing Process

The Elections Code requires the Board to hold at least one public hearing on any proposal to adjust the boundaries of a district, prior to the public hearing at which the Board votes to approve the proposal. In addition to these two public hearings, the process must also allow sufficient time for two readings of the ordinance enactina the new district boundaries and sufficient time for staff to

and Congress, in order to meet the deadlines prescribed by the Special Districts elections in November, and the March Primary election.

As directed by your Board, staff has prepared maps demonstrating your Board's proposed county-wide plan and the LULAC alternative plan for the 4th and 2nd District boundaries. These maps have been placed on file with the Clerk of the Board, and have been made available to citizens and groups that have requested them. The maps were also placed on the County's website. In addition, the plans were provided in the County's redistricting software, and made available on the public use computer, which is located in the lobby of the Elections department. The public hearing was noticed as required, in the Santa Cruz Sentinel and the Register-Pajaronian, in both English and Spanish.

It is therefore RECOMMENDED that your Board:

- 1. Accept and file this report on the Redistricting of Supervisorial boundaries;
- 2. Open the public hearing on Redistricting and accept public comment;
- 3. Determine those boundaries to be adjusted to reflect your Board's decision on redistricting;
- 4. Set a second public hearing for August 14, 2001, at a time to be designated by your Board, for the purpose of further considering a redistricting plan or plans, or to adopt a redistricting plan; and in preparation for adopting said plan,
- **5.** Direct County Counsel to prepare an ordinance to adopt the redistricting plan that is designated by your Board.






Proposed Boundary Change for 3rd and 5th Districts


Proposed Boundary Change for 1st and 3rd Districts
