RESOLUTION AUTHORIZING TEMPORARY TRANSFER OF FUNDS

WHEREAS, Article XVI, Section 6, of the Constitution of the State of California provides that it shall be the duty of the Treasurer of any county to provide funds for meeting the obligations incurred for operation and maintenance purposed by any political subdivision whose funds are in his custody and are paid solely through his office: and

WHEREAS, it is necessary that the sums <u>listed below</u> be transferred from the funds in the custody of the Treasurer of the County of **Santa Cruz** to the <u>Districts listed below</u> for meeting the obligations incurred for operation and maintenance of the Districts through <u>the dates listed below</u>.

That the Treasurer of the County of **Santa** Cruz be and is hereby authorized and directed to transfer from the funds in his custody to the <u>district</u> listed above the <u>sums</u> as <u>listed above</u>, said sums to be used for meeting the obligations incurred for operation and maintenance purposed only **for** said District.
- 2. Said transfer of sums shall be made by the Treasurer of the County of **Santa Cruz** only to the extent that said sums as <u>listed above</u> do not exceed **85**% of the taxes accruing to said District before any other obligations of said District are met from such tax. Such repayment shall be with interest at the rate received on similar investments by the County on the date this Resolution is adopted, as determined by the County Treasurer, or the cost of borrowing, whichever is greater.
