#### RECOGNIZE AND CERTIFY THE SEIU - LOCAL 415 AS THE BONA FIDE **EXCLUSIVE LABOR ORGANIZATION REPRESENTING** TEMPORARY EMPLOYEES IN RELATED CLASSIFICATIONS

Dear Members of the Board:

On June 5, 2001 your Board adopted resolution 207-2001 recognizing the right of temporary employees to associate themselves together for their mutual benefit and to organize and collectively bargain, if that was their desire. That same resolution stated that the County would recognize and certify the labor organization that presented it with authorization cards validly signed by a majority of the affected employees, as the exclusive authorized bargaining agent for those employees.

Following adoption of that resolution Service Employees International Union (SEIU) Local 415 distributed authorization cards to active temporary employees eligible to submit cards. Temporary employees eligible to vote were those currently employed, and occupying positions in classifications in the General Representative Unit in which there are budgeted positions. Also eligible to vote were currently employed temporary employees occupying extra help only positions that are related to the existing general representation unit classes. Specifically, these classes were: Acquatics Aide, Lifeguard/Instructor, Park Services Officer I, Parks, Recreation and Cultural Worker I, II, III and IV and Student Workers I, II, III, and IV. There were 240 temporary employees eligible to sign authorization cards.

On July 26, 2001 SEIU - Local 415 submitted its collected authorization cards to the Elections Department. On July 30, 2001 the Elections Department counted the cards and certified that there were 131 cards, 54.6%, that authorized SEIU Local 415 to represent affected temporary employees for purposes of collective bargaining with the County.

WHEREAS, it is the desire of the County of Santa Cruz to encourage the right of its employees to organize for their mutual benefit; and

WHEREAS, the County of Santa Cruz on June 5, 2001 adopted Resolution No. 207-2001 providing a procedure for employee organizations to submit authorization cards for the right to represent temporary employees; and

WHEREAS, the Service Employees International Union (SEIU) Local **415** did, on July 26, 2001 submit such cards to County of Santa Cruz Elections Department for counting to occur on July 30,2001; and

WHEREAS, the County of Santa Cruz did count those authorization cards and certified that a majority of eligible temporary employees submitted cards authorizing the SEIU Local 415 to represent them for purposes of collective bargaining;

NOW, THEREFORE, BE IT RESOLVED that the Santa Cruz County Board of Supervisors hereby accepts the certified Statement of Vote and recognizes the SEIU Local 415 as the exclusive authorized bargaining agent for those temporary employees occupying classes in the general representation unit and related extra help only classes.
