APPROVAL OF CONSOLIDATED COMMUNITY ACTION BOARD WELFARE-TO-WORK CONTRACT

Dear Members of the Board:

As part of the Human Resources Agency (HRA) budget for fiscal year 2001-2002, your Board approved funding for four welfare-to-work services for CalWORKs participants provided by the Community Action Board (CAB), including the Work-Related Emergency Payments Fund, Earned Income Tax Credit Hotline, Women Ventures non-traditional jobs program, and the Carpool Incentives Program. The purpose of this letter is to recommend approval of a consolidated contract with CAB to provide all four services.

During FY 2000-2001, the funding for the four contracts came from two 'different sources: a Job Access Reverse Commute (JARC) grant for the Carpool Incentive Program and the CalWORKs single allocation for the other three programs. The JARC grant is coming to an end on September 30, 2001, however, the Carpool Incentives Program will continue to be funded by the CalWORKs single allocation. Because the funding is now from a single source and the services are all provided to the CalWORKs population, HRA is recommending consolidation of the four program elements into one contract this year for a total amount of \$266,000. A consolidated contract has been signed by the contractor and approved by County Counsel and Risk Management. It is on file with the Clerk of the Board.
