On August 7,2001, the Board of Supervisors received four bids for the subject project. All bids were found to be in order. The engineer's estimate was \$26,000. The low bidder was Earthworks of Santa Cruz, California in the amount of \$28,500. Sufficient funds are available in the County Service Area No. 28 budget to cover this expenditure, including contingencies and administration.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of Earthworks in the amount of \$28,500 and authorize the award of contract.

**2.** Authorize the Director of Public Works to sign said contract on behalf of the County of Santa Cruz.
