SUBJECT: BONNY DOON ROAD STORM DAMAGE REPAIR, BM 0.69 AND 0.74

DSRNOS. 27212 AND 27213

Members of the Board:

The plans, specifications, and engineer's estimate for the subject storm damage repair project are now complete and presented here for your consideration and approval. The work provides for the minor storm damage repair of the failed roadside embankment and culvert on Bonny Doon Road, along with other improvements related to fish passage enhancements. The work at PM 0.74 is supplemented by fbnding provided by a California State Fish and Game grant (approved by your Board on June 12,2001) which allows for the replacement of the PM 0.74 pipe with a new culvert in order to enhance steelhead trout migration. In addition, similar to work along Bonny Doon Road that was completed last year, RMC Pacific Materials (previously RMC Lonestar Industries) is actively supporting the fishery enhancement process along Bonny Doon Road by providing the large quarry stone needed for both damage sites at no cost to the County or Fish and Game. Public Works has also been granted permission by County Planning to obtain and transport the stone from the RMC quarry. Public Works is also working with County Planning and Fish and Game on the various permits required for implementation of these improvements and repairs.

Outside of the fish passage enhancements, the road work proposed is limited to those repairs included in the approved Damage Survey Reports (DSR), so as to return the two damage sites to their original predisaster condition. The plans and specifications thus provide for a repair that essentially matches the existing roadway in the vicinity of the repair site, pursuant to the Federal Emergency Management Agency's (FEMA) approved scope of work and available fbnding. In those instances where the fbnding approved for a DSR repair falls short of the actual bid price, we will submit a supplemental fbnding request to FEMA requesting that they cover the fbll cost of repairing the roadway.

The engineer's estimate for this work is \$70,000, not including contingencies or administration costs. Sufficient funding for the project was included in the approved 2001/2002 Road Program.

It **is** therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids for the Bonny Doon Road Storm Damage Repair Project.
- 2. Set the bid opening for 10:45 A.M. on September 11, 2001.
- 3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning August 25, 2001, in accordance with the provisions of Public Contract Code Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m.**, **September 11,2001**, and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County road in accordance with the specifications therefor, to which special reference is made, as follows:

BONNY DOON ROAD STORM DAMAGE REPAIR, PM 0.69 AND 0.74, DSR Nos. 27212 AND 27213

This project involves the placement of Rock Slope Protection (Method A), constructing fish pools at P.M. 0.69, replacing a culvert, and constructing headwalls and wingwalls at P.M. 0.74.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required.

The successful bidder shall furnish a payment bond and a performance bond.

The Contractor shall possess a Class A license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
