Redistricting of Supervisorial Boundaries - Ordinance Establishing 2001 Boundaries

Dear Members of the Board:

On August **14,2001**, your Board directed our office to coordinate with County Counsel to develop an ordinance to amend the existing County Code, and establish the County of Santa Cruz Supervisorial District boundaries for **2001**. The ordinance references a set of maps, entitled "County of Santa Cruz Supervisorial District Boundaries **2001**" which reflect your Board's proposed redistricting plan, and an attachment, which lists all property parcels contained in each of the five supervisorial districts. The maps with attachments have been placed on file with the Clerk of the Board.

The adoption of this ordinance is in accordance with Section **21501** of the Elections Code, which specifies that the boundaries of the supervisorial districts shall be adjusted by the board before the first day of November of the year following the year in which each decennial federal census is taken. The second reading of this ordinance is scheduled for August **28**, **2001**, and the effective date will be on the **31**st day after that reading.

It is therefore RECOMMENDED that your Board approve in concept the ordinance amending Chapter 2.04 of the Santa Cruz County Code, establishing the 2001 Supervisorial District boundaries, and direct that the ordinance be placed on the August 28, 2001 agenda for final action.

ORDINANCE AMENDING CHAPTER 2.04 OF THE SANTA CRUZ COUNTY CODE RELATING TO ESTABLISHING 2001 SUPERVISORIAL DISTRICT BOUNDARIES

The Board of Supervisors of the County of Santa Cruz ordains as follows:

SECTION

Chapter 2.04 of the Santa Cruz County Code is hereby amended to read as follows:

Chapter 2.04

SUPERVISORIAL DISTRICTS

2.04.010 Supervisorial District Boundaries.

The boundaries of Supervisorial Districts One through Five are established as shown on the map set entitled "County of Santa Cruz Supervisorial District Boundaries 2001," as adopted August 21, 2001, on file with the Clerk of the Board of Supervisors. All property parcels that are contained in each of the Supervisorial Districts One through Five are provided as an attachment to the map set, and are placed on file with the Clerk of the Board of Supervisors. In the event of any conflict between the map set and the parcel list on file, the boundaries shown on the County's Geographic Information System's Supervisorial District Boundary Data Layer shall prevail.

SECTION II

This ordinance shall take effect on the 31st day after the date of final passage.
