Michael Nieto and his parents Tom and Lorri Nieto, by and through their legal counsel Foley & Lardner, ("Claimaint") make this claim against Scotts Valley Unified School District, Santa Cruz County Mental Health, Santa Cruz County Office of Education, and Santa Cruz County for personal injury suffered on May 10,2001 while in attendance at the Special Education classroom located at Bonny Doon Elementary School.

- 2. Notices concerning the claim should be sent to Nancy J. Geenen, Foley & Larcher, One Maritime Plaza, 6th Floor, San Francisco, California 941 1.
- 3. Michael Nieto suffered a severed tendon on May 10,2001 at approximately 2:30 p.m. in the Special Education Classroom located at Bonny Doon Elementary School.
- 4. At the above time and place, Michael Nieto was under the supervision of the classroom teacher Susan Aumann, Michael's personal classroom aide Garrett Conway, the occupational therapist Cindy Brown, and the classroom therapist Steve Rockhold. Michael is severely emotionally disturbed and known to be a danger to himself and others. During a classroom activity, Michael's was provided with a knife to cut fruit for fruit salad. Due to the negligent supervision of the adults charged with Michael's care, Michael cut his thumb and severely injured the tendon.
- 5. Michael's injuries include **a** severed tendon and emotional distress. Michael's mother suffered lost wages because she left worked to take Michael to the emergency room. Michael's mother and father suffered emotional distress.
- 6. The names of the persons responsible for Michael's injuries include Susan Aumann. Steve Rockhold, Cindy Brown, and Garret Conway
- 7. The claim amount exceeds \$10,000 and is in an amount that would place the claim within the jurisdiction of the Superior Court for the County of Santa Cruz. The claim is based on the personal injury to Michael including permanent physical injury, pain and suffering, emotional distress, emotional distress to Michael's mother, expenses, loss of wages, and past and future medical expenses.

If any of the entities to whom this claim is presented have specific forms for filing a claim of this nature, please send the form to the undersigned within 7 days of receipt of this claim notification. If for any reason you believe this notice is insufficient for any reason, please provide the undersigned with written notice of the insufficiencies within 20 days of the date of this letter.
