RE: Accident of July 7,2001 on Valencia Rd at intersection with Valencia School Rd.

To whom it may concern:

Santa Cruz, CA 95060

I own a house in 2918 Scriver St., Santa Cruz, CA 95062 where I was spending some vacation time.

On Saturday, July 7,2001 I was on a bicycle ride traveling on Valencia Rd. towards Freedom Blvd and at around noon I fell down from my bicycle because of a large crater left on the road at the intersection with Valencia School Rd.

As I was exiting an area surrounded by Redwood trees and very much in the shade, I found my bicycle lane suddenly interrupted by this crater and could not change direction in order to avoid entering the car traffic lane and oncoming traffic. My front wheel landed on the crater left on my right bicycle lane of Valencia Road and I was thrown off my bicycle landing on my head and left body. My helmet was broken (this saved my head), I suffered a severe concussion and several abrasions on my left side (shoulder, knee, elbow).

This crater was a result of neglect from your department, I was told by passing by cyclists that stopped for help out that it had been there for months and already had reported this anomaly to your department. I think it is irresponsible to leave such a hazard on a well-traveled road like Valencia and for such a long period of time.

I reported this accident to the local sheriff and I was told by my cyclist friends that regularly ride on Valencia Road (for their daily training), that as a result of my accident, this crater was filled the day after my accident occurred.

I have suffered material damages, injuries and damage to my equipment as a result of this accident. I have also missed time at work nursingmy concussion and injuries.

I am holding the Santa Cruz Public Works department responsible for neglecting such basic, maintenance on Valencia Road and I am requesting that my damages be covered for the amount of \$1,000.00 (One thousand dollars).

Please contact me to resolve this matter. **If** I do not hear from you in the next fifteen days from receipt of this letter, I will pursue this matter further by following the legal channels for my protection under the California law.
