Adopt Resolution Accepting Unanticipated Revenue for Weed Management Area

Dear Members of the Board:

On April 24, 2001, your Board approved and authorized the Agricultural Commissioner to sign an agreement with the California Department of Food and Agriculture (CDFA) for a Weed Management Plan, and adopted a resolution accepting and appropriating unanticipated revenue for expenses related to weed management activities. The total amount payable under the agreement approved by your Board was \$11,238 (\$6,573 for FY 00/01 and \$4,755 for FY 01/02). The \$4,755 was not included in the budget approved for FY 01/02. In addition, some of the work planned for FY 00/01 was performed in FY 01/02. Consequently, the amount of \$1,474 from FY 00/01 has been re-budgeted to FY 01/02. The total revenue now available for FY 01/02 is \$6, 229.

To receive and use this revenue, it is necessary for your Board to adopt a resolution accepting and appropriating the unanticipated revenue. The revenue will be used for the weed management activities already approved by your Board. These expenses include staff salaries and benefits, production of a yellow starthistle (YST) brochure, and continued work on control of Harding grass at a slough restoration site in Watsonville.

It is therefore RECOMMENDED that your Board adopt the attached resolution accepting and appropriating \$6,229.00 into Agricultural Commissioner Budget Unit 103210 to be used for expenses related to weed management activities.
