SUBJECT: 2001/2002 PAVEMENT MANAGEMENT DIGOUT PROJECT

Members of the Board:

The specifications and engineer's estimate for the subject project are complete and presented here for your consideration and approval. The project proposes to prepare damaged areas of County roads for seal coating through digouts.


The engineer's estimate for this project is \$675,000, not including contingencies and administration. Sufficient funds are available in the 2001/2002 Road Budget to cover this expenditure.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the specifications and engineer's estimate and authorize calling for bids.
2. Set the bid opening for 10:45 a.m. on September 25, 2001.

3. Direct the Clerk of the Board to advertise the attached Notice to Contractors for a ten-day period beginning September 2, 2001, in accordance with the provisions of Public Contract Code Section 20392.



Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., SEPTEMBER 25, 2001**, and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County roads in accordance with the specifications therefor, to which special reference is made, as follows:

The successful bidder shall furnish a payment bond and a performance bond


The contractor shall possess a Class A license at the time that this contract is awarded.
