On August 10, 2001, the Kase Pacific Construction Company completed the County Government Center Room 120 Remodel Project. The original bid amount was \$75,647. One approved change order was issued for \$1,925 which provided for painting of walls not originally included in the scope of work. The total construction cost for this project is \$77,572.

It is therefore RECOMMENDED that your Board take the following actions:

- 2) Approve the final cost of \$77,572; and
