On August 16, 2001, Bogner Sheet Metal Company completed the installation of a new gas fired HVAC unit and new duct work to complete the Redwoods Classroom A/C Upgrade Project. The original bid amount was \$23,656. One approved change order was issued for this project for \$1,436 to add a factory installed energy economizer and coil guard. The total construction cost for this project is \$25,092.

It is therefore RECOMMENDED that your Board take the following actions:

- 1) Accept the project as completed;
- 2) Approve the final cost of \$25,092; and
- 3) Authorize the Clerk of the Board to file the executed Notice of Completion with the Office of the County Recorder, **a** copy of which is attached.
