RE: Clean Beach Initiative Project at Seabright Beach

Dear Members of the Board:

The 2001-02 State budget includes \$32 million in Clean Beaches Initiative grant funding for 38 projects designed to reduce the health risk from contaminated water at state beaches. These projects include improvements to storm drains and sanitary sewer systems in order to reduce discharge of bacteria to beach areas. The source of this funding is The Costa-Machado Water Act of 2000 (Proposition 13).

Four projects in Santa Cruz County have been proposed for grant funding in the current year: Seabright Beach (\$325,000), Main and Cowell Beach (\$150,000), Capitola Beach (\$100,000) and Main and Seabright Beach (\$1,000,000). Three of these projects designate the County of Santa Cruz or the respective city as the lead agency. However, the project at Seabright Beach lists the County of Santa Cruz as the sole responsible agency. Since that project is located within the City of Santa Cruz, it may be more appropriate to transfer lead responsibility of the project to the City, with Environmental Health staff providing assistance, similar to the three other projects. To implement this transfer, the State has requested a resolution from your Board relinquishing contractor status to the City of Santa Cruz.

It is therefore RECOMMENDED that your Board:

1. Adopt the attached resolution Relinquishing Prime Contractor Status for the Clean Beaches Initiative Project at Seabright Beach.

WHEREAS the County of Santa Cruz is listed as the sole agency on the proposed grant award for the Proposition 13, Coastal Nonpoint Source Program Clean Beaches Initiative project at Seabright Beach in the Budget Act of 2001; and
